OVERRIDE CONTINUATION

Maintenance and operations overrides fund people and programs. Peoria Unified has had one in place for 24 years to fund:

- Nurses/health services at every school
- Athletic programs
- Extra/co-curricular activities
- Art, band and chorus
- Assistant principals at every school
- All-day kindergarten
- Maintains class sizes
- Reading programs
- Physical education
- Gifted education

YES

A yes vote for the override continuation: The district would keep the programs and people listed above.

NO

A no vote for the override: The district will be required to eliminate 29 million a year from its annual budget, with reductions over the next two fiscal years. With the loss of funding, the positions and programs listed above are at risk of being reduced or eliminated.

The override continuation is not a new tax.

If approved, it would result in an estimated average annual tax rate of \$1.4486 per \$100 of limited assessed valuation for residential property owners.

CRITICAL NEEDS BOND

Bonds fund capital projects and cannot be used for salaries. This bond will address priority building and campus maintenance needs:

- Priority building and campus maintenance needs
- Safety and proper function of aging buildings
- Land purchase which can be used for northern district high school
- Buses
- Technology

YES

A yes vote for the critical needs bond: Fund building renovation projects at all schools including heating, air conditioning, parking, roofing and restroom repairs; implement safety features at all schools; replace student and staff technology devices, servers and technological infrastructure; replace student transportation vehicles; acquire land for future high school construction.

NO

A no vote for the critical needs bond: Required maintenance and facility updates will not take place, students and staff will go without technology, aging buses will not be replaced and land for future high school will not be acquired.

If approved, the bond rate will not increase.

The bond secondary property tax rate is expected to remain at or below \$1.4781 per \$100 of residential limited assessed valuation.

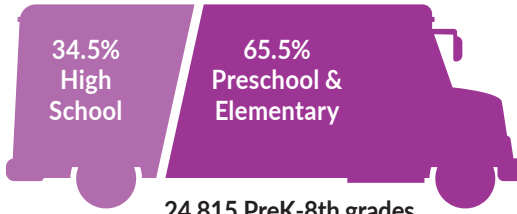
STRATEGIC PLAN

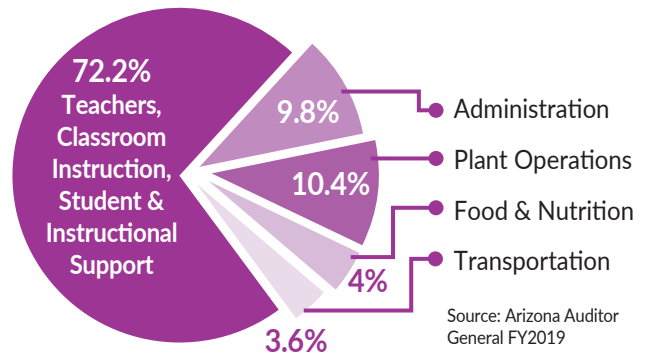

Support Students & Save Money! SCHOOL TAX CREDIT

Did you know that anyone who resides in the state of Arizona and pays state taxes can contribute to a school or towards a child's extracurricular activities through a tax credit donation? You don't have to have a student in enrolled in Peoria Unified to donate.

The Arizona School Tax Credit Law allows taxpayers a Tax Credit for contributions made to extracurricular activities: \$400 for those filing personal taxes as "married filing jointly" or \$200 for those filing "head of household" or "single." Peoria Unified recommends consulting a tax adviser about qualifications for the dollar-for-dollar credit.
