

Need Money to Help Pay for College? You are not alone. Filling out the FASFA form is the first step to getting financial aid. It is the application required by all schools in awarding federal student aid to those who qualify. The FASFA form helps you get access to get:

- Federal Grants
- Federal student loans
- Federal work study
- State loans
- State grants and scholarships
- Grants and scholarships from other organizations.

What is FASFA?

The FAFSA is the application students fill out in order to determine their financial aid eligibility. FAFSA needs to be filled out each academic year. You can submit a FAFSA at www.fafsa.gov.

Are you a U.S. citizen?

You must select the option that indicates your citizenship status.

Select U.S. citizen (or U.S. national) if you are a U.S. citizen or U.S. national.

Select Eligible noncitizen if you are:

- A U.S. permanent resident, with a Permanent Resident Card (I-551), or a Conditional permanent resident (I-551C)
- Other eligible noncitizen with an Arrival-Departure Record (I-94) from the Department of Homeland Security showing any one of the following designations: "Refugee,"

What is a Pell Grant?

Federal Pell Grant

(does not have to be repaid)


FOR undergraduates with exceptional financial need who have not earned bachelor's or professional degrees.

AMOUNTS can change annually. For 2018–19 (July 1, 2018 to June 30, 2019), the award amount is \$5,920.

What is work study?

- For undergraduate and graduate students; part-time jobs can be on campus or off campus. Money is earned while attending school.
- Does not have to be repaid.



What is a Student loan?

 Student loans, unlike grants and work-study, are borrowed money that must be repaid, with interest, just like car loans and home mortgages. You cannot have these loans canceled because you didn't like the education you received, didn't get a job in your field of study, or are having financial difficulty. So think about the amount you'll have to repay before you take out a loan.



A good approach to financial aid is:

- First, accept free money (scholarships and grants), i.e., funds you don't have to pay back;
- Then, accept earned money (work-study), i.e., funds you earn through a job; and
- Finally, accept borrowed money (student loans), i.e., money you have to pay back with interest.
