

Items for Student and Family Focus

Centennial provides a safe and welcoming environment to every student. Our students must follow the handbook guidelines to promote safety, maximize instructional time, and provide the circumstances necessary for every student's success. Your signature on the front page indicates your understanding of each of the following:

TARDY/LATE: Students must arrive on time to class to learn and achieve. When students arrive late, they disrupt class and miss important instruction. Students who are more than 30 minutes late will be marked absent for the entire class period. Parents may excuse up to five first-period tardies per semester. Administration will conference with students who are late a fifth time. As of a student's sixth tardy, he/she will remain in Sweep detention for the remainder of any first period in which he/she is tardy. Students who continue to be tardy to class will serve lunch detentions. Students who accumulate 8-9 tardies will serve an After-school Wednesday Detention from 12:30-1:30PM.

ABSENCES: Students should attend school every day. Parents must report absences to the attendance office by calling 623-412-4405. Documentation for absences, such as doctor notes, can be dropped off to the attendance secretary. Students may lose credit for any class in which their absences exceed 10% of the course's total instructional days.

CLOSED CAMPUS: Centennial is a closed campus. No student may leave campus during the school day unless he/she is signed out by a parent. Centennial must have written verification and parent contact for any students to leave campus.

SKATEBOARDS/BIKES: Centennial provides an area for students to lock bikes and skateboards. Students may not ride bikes or skateboards on school grounds. Students may not carry or store skateboards or bikes on campus. Students bring personal items to campus at their own risk.

FOOD/DRINK: For the health and safety of all students, food and drink is permitted in the cafeteria, snack bar and designated eating areas only. *Food is never permitted in classrooms.* ONLY water is permitted. Students will be asked to discard any food or drink brought into classroom buildings. **Food/drink deliveries from outside companies such as: Uber Eats, Doordash, Grubhub, Postmates, pizza deliveries or the like are not permitted on campus. Food/drink brought by parents will be held up front until the student's lunch time/after school.**

ID BADGES: Students and staff must wear ID badges on the front of their person and keep the badges visible throughout the school day. Students may wear a lanyard displaying the badge or clip the badge to the front of their shirts or belts. Students must present their ID upon request from any staff member. In order to promote Centennial provides one free ID badge to each student at the start of each school year. Students may purchase a replacement ID for \$5 in the bookstore. Students use their ID badges to access services and entry into the library, attendance office, cafeteria, and athletic events.

DRESS CODE: Students must adhere to the dress code outlined in the student handbook. Students who violate the dress code will be required to change their clothes into something loaned to them by the school, have parents bring them appropriate clothing, or arrange for their parents to pick them up from school. Students who borrow clothing from the school will need to give it back laundered and will receive their item of clothing upon return. A student will not be sent back to class until his/her clothing is within dress code. Repeated or egregious dress code violations may result in disciplinary consequences.

CELL PHONE/ELECTRONIC DEVICE: Students may use their phones before and after school, during passing periods, and at lunch, but in order to promote classroom learning and avoid disruptions, **students may not use cell phones during instructional time**, unless specifically authorized for educational purposes by the classroom teacher. Students should please keep their devices off and concealed during class. Unauthorized use of cell phones, earbuds, headphones, portable sound systems, and the like, may result in confiscation: 1st offense=phone confiscated and sent to receptionist, where student may pick it up at the end of the day. 2nd offense=same as first plus a lunch detention. 3rd offense=phone confiscated and parents or an emergency contact must pick up confiscated device at the end of the day. Further violations will result in escalating consequences and require parent pick up at the end of the school day.

SOCIAL MEDIA: Students must use social media responsibly. Students will be subject to school consequences if administration determines that they use social media to bully, harass, attack, or demean students or staff. Please report harassing online behavior to administration.

SEVERE VIOLATIONS: Violations such as fighting, use or possession of drugs, wax pens, tobacco, vapes, e-cigarettes, lighters, weapons, or alcohol will result in off-campus suspension and referral to the police. Open enrollment students may lose their variances. Repeated violations will result in long-term suspension.

CAMERAS: To support the safety of our students, video cameras are present on the campus and on school buses.
