



GCU Dual Enrollment Overview

Thank you for your interest in being a part of Grand Canyon University's Dual Enrollment program, we're so excited to have you! For your convenience, we have compiled need-to-know information and answers to some common questions in order to help support you in your class. Please read all of the below steps and save this information for your records just in case you have questions outside of our business hours.

Apply for Dual Enrollment with GCU

If you are interest in earning dual enrollment credits with GCU, you must first complete an online application on http://apply.gcu.edu as a "Dual High School Student." You must complete this application even if you have already applied to GCU for a Bachelor's degree. You may have already been told you will be completing this application at your high school or you may have been assigned to complete this at home.

Review Official Transcripts

Your official high school transcripts are used to verify your GPA and your grade level. Sophomores must have at least a 3.25 unweighted GPA; Juniors and Seniors must have at least a 3.0 unweighted GPA. Transcripts must be official and signed by your high school counselor. These need to be submitted directly to GCU by a school representative. GCU can accept paper or electronic copies.

Complete the Parent Authorization Form (PAF)

This form certifies that your parent or guardian has given you permission to enroll as a GCU dual enrollment student. This form must be completed by hand and any mistakes must have a line through them and be initialed.

Complete the Student Information Release Form (SIRF)

If you would like your parent/guardian to be able to access your files, you need to fill out the Student Information Release form. **WITHOUT THIS FORM, GCU CANNOT DISCLOSE ANY INFORMATION TO YOUR FAMILY EVEN IF YOU ARE A MINOR.** This is not required but is strongly recommended. GCU must follow the Family Educational Rights and Privacy Act of 1974 and, as such, we will not be able to speak to family members regarding the student unless this form is completed in full. All mistakes must have a line through them and must be initialed.

Take a Placement Exam

You will need to take a placement exam if you are interested in enrolling in either a math and/or English course for the first time with GCU. You have two attempts to successfully pass a placement exam, as well as unlimited practice exams. This can be done after completing the online application. Placement exam links can be provided by your dual enrollment counselor or can be found on your student portal.

Course Tuition

Tuition is \$52.50 per credit and dual enrollment courses are 4 credits. Students taking dual enrollment courses at their high school may be eligible to complete a tuition waiver if they receive free/reduced lunch or are a part of any of the following federal benefits programs: Supplemental Social Security, SNAP, TANF, WIC or AHCCCS. You can also check with your counselor to see if your school is partnered with GCU to provide any additional scholarships.

Refund and Withdrawal Policy

Students cannot unregister or earn a refund after **9/30/17**. After this date, a student's course will appear with a grade on their transcripts. In addition, once a student enters the final two weeks of their class, they cannot drop the course and will earn an A-F grade for the course rather than a "W" for withdrawn. Any withdrawal requests must be sent directly to your GCU dual enrollment counselor or dualenrollment@gcu.edu. You cannot ask your teacher to do this for you.

Student Portal Access

About 24 hours after you apply to GCU, you will receive an email from technical support with your user name and password for your student portal. This is the area where you access all of your electronic materials, our library, submit tuition payments, complete placement exams and many other helpful components. You will have access to http://myportal.gcu.edu with the user name and password provided. If you do not receive that email or lose it, you must contact dualenrollment@gcu.edu or 855-428-8002 for a student portal reset.

Contacting GCU

You can contact our dual enrollment team directly if you have any questions or need any assistance with the application or registration process. Each student will be assigned an individual counselor once they have completed an online application. Your individual counselor's name and information are located on your student portal homepage. If you have questions before receiving that access, you may contact dualenrollment@gcu.edu or call 855-428-8002. If you are ever having technical difficulties, you can contact GCU's technical support team at 602-639-7200. If you need assistance at any time before, during, or after your dual enrollment course feel free to reach out directly to GCU because we'd love to assist you.
