

# Matirst Scholars



#### **Eligibility requirements**

Students who apply to the First Scholars program must:

- Be a first-generation student, meaning neither parent(s) or guardian(s) have earned a bachelor's degree.
- Be a first-time student who has been admitted to NAU for the 2024–2025 year. This includes submitting appropriate application and enrollment fees, and high school transcripts.
- Demonstrate financial need and <u>complete the FAFSA</u> (Free Application for Federal Student Aid). (Due to changes concerning the 2024-2025 FAFSA, we recommend that you complete the application as soon as possible.)
- Be a US citizen or qualified non-citizen as defined by federal law.
- Be eligible for in-state tuition.
- Be willing to participate fully in the First Scholars program and activities for four years.

### **Program requirements**

Students selected to be a First Scholar must:

- Commit to four years of support and guidance from the First Scholars Program
- Attend an NAU new student orientation
- Attend the First Scholars orientation (date to be determined for Fall 2024)
- Participate in designated socials, events, workshops, and service projects for four years
- Meet with a peer mentor their first year
- Meet with a professional staff mentor for four years
- Maintain a 2.0 GPA, semester and cumulative.

## <u>Union Plus</u> <u>Scholarship Program</u>

Current and retired members of participating unions, their spouses and their dependent children.

A GPA of 3.0 or higher is recommended. The required essays can account for up to half your total score. Amounts range from \$500 to \$4,000. These one-time cash awards are for study beginning in the Fall of 2022. Students may re-apply each year.

## WHY SHOULD I TAKE THE ACT?

#### Applying to a Test-Optional school.

Even at test-optional schools, submitting an ACT score can be highly beneficial. Students who provide test scores often have higher admission rates1, and many test-optional schools require scores for scholarships or entry into specific programs like nursing and engineering. ACT results can also meet math, English, or STEM prerequisites, helping students avoid extra placement tests.




### Not sure what to do after high school.

Even if plans aren't clear yet, having an ACT score can help students be prepared for future college and career opportunities.

Students who may be reluctant to take the ACT initially are often pleasantly surprised when they score better than expected and discover new options to consider for college and career success. Also, completing the interest inventories on MyACT or Encourage can reveal strengths and interests to help guide students' paths. Get helpful suggestions for deciding next steps after high school.

#### Going to trade school.

While ACT test scores aren't usually required for trade schools, submitting an ACT score may help a student stand out. A high score may allow students to bypass placement exams and qualify for certain programs or scholarships. It also keeps options open if students decide to transfer to a college later.



Taking the ACT in high school is often easier than preparing for the test a few years later and ensures students will have a score whenever they choose to apply to college.

## Enlisting in the Military.

Students enlisting in the military will need to take the Armed Services Vocational Aptitude Battery (ASVAB) exam. However, having an ACT score can be beneficial if a student decides to pursue college while in the military or after service, making the college application process easier.

The <u>Arizona Teachers Academy</u> (ATA) is a program to help pay for tuition and fees for those students in a state university or community college Educator Preparation Program (EPP). The scholarship covers tuition and mandatory fees after a student has accepted all other non-loan aid such as institutional scholarships, federal Pell grants, and other private scholarships. To receive the ATA scholarship, you must commit to one year of teaching in an Arizona public school for each year you receive the scholarship. Visit this **website** for more information.


